*Sanctioned Event: Any OHSF, BASS JH/HS Fishing, and/or MLF JH/HS Fishing event

2024 D WYLIE JH/HS

BIG BITE CHALLENGE RULES:

- 1. D Wylie JH/HS BigBite Challenge yearly registration fee is \$100 per 2-man team.
- 2. JH/HS 2-Man team consists of 2 JH/HS anglers. Upon creating registration the team must denote the 2 JH/HS anglers as well as denote one of these two anglers JH/HS Team Captain.
- 3. If JH/HS Team fishes a sanctioned JH/HS event with a substitute (one not noted as team member at D Wylie registration) only the 2 stated anglers listed in D Wylie registration will be qualified to fish in the D Wylie JH/HS BigBite Challenge Championship.
- 4. JH/HS 2-man Team Captain will receive a 1099 if winnings are over \$599.00 and will be required to fill out our Release of Liability Form before checks are issued. Checks are no longer valid if not cashed within 90 days.
- 5. In the event of a team split or partner cancellation, championship qualification will stay with the JH/HS angler denoted as Team Captain. If the Team Captain is unable to participate the 2nd JH/HS team angler will be noted as the championship qualifying angler.
- 6. To qualify for the D Wylie JH/HS BigBite Challenge Championship a JH/HS Team must finish in the top 10% of JH/HS Teams weighing fish in qualifying events.
- 7. Contest begins August 1, 2023 and ends July 31, 2024
- 8. Registration paid online must be before official takeoff at a sanctioned event.
- All winners are subject to polygraph. If polygraph is failed your submission will be voided and you will be disqualified without refund from this year's event.
- 10. JH/HS Teams may register for the D Wyile JH/HS Bigbite Challenge throughout the season, however only teams registered PRIOR to fishing an event will be considered. (with exception of events fished August 1, 2023 to December 31, 2023)
- 11. Any JH/HS Team may only qualify once for the D Wylie JH/HS BigBite Challenge Championship. A JH/HS Team will not be able to double qualify.
- 12. Once a JH/HS Team qualifies for the D Wylie JH/HS BigBite Challenge Championship they will not be considered in the top 10% placings for qualification at future sanction events in 2024. Example: Team A qualifies in the top 10% in Event 1. In Event 2 there are 100 teams fishing so 10 teams will be qualified for the championship. If Team A finishes in one of those top 10 teams they will not be eligible to qualify a 2nd time and the JH/HS Team placing 11th will qualify for the championship.
- 13. Top 10% of JH/HS Teams weighing fish at each sanctioned event in 2024 will qualify to fish in the entry free D Wylie JH/HS BigBite Challenge Championship.

- 14. Championship qualifying teams will receive championship registration information via email.
- 15. The Championship event will be a team event on Oklahoma Lake in June or July, 2024 to be announced.
- 16. To fish the Championship event a qualifying JH/HS Team must be the 2 anglers as stated upon registration. If one registered member of a qualifying JH/HS Team is unable to fish the D Wylie JH/HS BigBite Challenge Championship for any unforeseen reason the qualifying JH/HS Team is allowed a substitute. The substitute must have fished at least one JH/HS sanctioned event in the 2024 season.
- 17. The cost of using a substitute will be \$50 and is paid during championship registration.
- 18. All D Wylie JH/HS BigBite Challenge Championship qualifying JH/HS Teams will be notified of their championship qualification via email. JH/HS Teams will be required to respond back to the email or notification is null and void.
- 19. All D Wylie JH/HS BigBite Challenge Championship qualifying JH/HS Teams will be required to register to fish the championship event. All championship qualification and registration information will be sent via email to qualifying JH/HS Team members.
- 20. Championship teams will be required to name their Boat Caption and substitute (if needed) at the time of championship event registration window. Changes to team members will not be allowed after the championship registration deadline has passed.
- 21. A substitute must be stated at championship registration. Changes to team members will not be allowed after the championship registration deadline has passed.
- 22. Eligible day's catch must be caught during tournament hours of a sanctioned event.
- 23. Eligible day's catch must be caught by an JH/HS Team anglers entered on registration to the D Wylie JH/HS Big Bite Challenge Championship.
- 24. Eligible day's catch must be caught in the state of Oklahoma.
- 25. Eligible day's catch must be a small mouth, large mouth or spotted bass species.
- 26. Eligible day's catch must be caught on rod and reel.
- 27. Eligible day's catch must be caught on artificial bait.
- 28. Must obey all state, lake, and tournament rules.
- 29. In the event of a tie, D Wylie JH/HS BigBite Challenge Championship will rely on said tournament rules tie breaker.
- 30. D Wylie JH/HS BigBite Challenge reserves the right to correct any misprints, inadvertent mistakes, or rules without notice.

- 31. All interpretations of the rules will be left exclusively to the D Wylie JH/HS BigBite Challenge staff.
- 32. All decisions are final, non-negotiable, and not subject to appeal.
